#### - INTERNATIONAL CORNER -

#### FROM DAN'S DESK

DAN HALSTROM, USMEF PRESIDENT AND CEO A CONTRACTOR TO THE BEEF CHECKOFF

Good Morning from Seoul South Korea where USMEF is leading the Heartland Team a group of 20 producers from a cross section (beef, pork, soybean, and corn) of Agriculture for an inside look into the South Korea and Japan Markets. Despite being two of our larger markets, there is still room for growth into key sectors such as the Convenience Store Sector, Ecommerce, and foodservice.

The July 2023 Beef Export data was seasonally lower with volume of 103,167 Metric Tons which was down 18 % from the record month in June 2022 (USDA compiled by USMEF). YTD Beef Export Volume through July 2023 stands at 772,343 Metric Tons which is down 11 % from last year's record. U.S. Beef saw increases in June for Taiwan, Mexico, South Africa, Canada, Peru and the EU.

#### - CHECK IN WITH THE CHECKOFF-

The Beef Promotion Operating Committee (BPOC) spent two very busy and intense days this month reviewing, discussing, and debating Beef Checkoff funding for fiscal 2024 programs. It's not an easy task when the funding requests are \$11 million more than the available funds, but when everything was finished, the BPOC allocated about \$38.5 million to 12 Authorization Requests. Following the BPOC Meeting, the CBB Executive Committee met and approved the full CBB budget, including these program budgets, to be submitted to the full Board and then USDA for final approval.
